• It has been confirmed with the Secretary of State's Office that a write-in candidate for Selectmen must be a registered voter to take the office.

BOARD UPDATES

• JM reported that he had spoken with the logger at the Van Dessel logging site regarding mud in the road (*Nute Rd*). He and AJ Hartford are working with Busby on construction estimates. He would recommend having Fisk come in to a Selectmen's meeting. He is working on arranging the seasons paving projects. He believes the soils are currently too wet at Champernowne.
