#### SELECT NOTES

The Select Board continues to move forward with several major long-term projects.

The development of a basic public works facility has begun. A committee of citizens and town officials is leading this effort. They are currently working on selecting a site for the facility. Action on site preparation and building a salt shed will follow. More information is available on the town website under the "Select Board" link. If you would like to help, please contact Town Administrator Eric Fiegenbaum at Town Hall.

Work also continues on how to improve Madbury's fire protection services for the future. Currently, the Board is working with Chief Perley exploring organizational options while the Chief is in contact with surrounding towns discussing collaboration possibilities. These efforts are informed by the Municipal Resources Inc. report on fire protection in Madbury which we received earlier this year. The report is available on the town website under the "Fire" link.

Speaking of websites, the Select Board is also moving forward with building a new town website. The new website is currently in its development phase and should be rolled out in the near future. It is our hope that the new site will improve information sharing and communication.

# TOWN OFFICE NEWS

**TOWN OFFICE CLOSURES**

**TAX BILLS:** Tax bills will be due in December. Please see your bill for the exact date.

**2025 Dog Licenses** will be available in January. A current rabies certificate is required. They are due by April 30, 2025.

**MADBURY TRANSFER STATION** will close for the season after the session on Saturday, November 16, 2024.

WINTER PARKING ORDINANCE will be in effect on November 1st and will remain in place until April 1st. It prohibits parking on streets and roads during snow plowing and removal operations. Any vehicle parked will be towed at the owner's expense. Placing of snow in the town road right of way during personal snow removal is prohibited as well. Your cooperation will help keep the roadways open and safe for all travelers.

The Board has also initiated an update to Town operations. Currently, the Town does not have a wage schedule for its employees. This means that if someone is to be hired for a particular position, there is no established pay range for that position. The Select Board is working to develop a wage schedule for the Town by collecting data from other communities that can be used for comparison. With a set wage schedule, the Town aims to ensure that employees are paid equitably for their work. This process is in the beginning stages.

Substantial maintenance was completed on Town buildings. Sections of the roofs of both the Town Hall and Safety Complex building needed to be replaced due to normal aging and wear. Several bids were obtained for the work in September, and the work was completed by early October. There was adequate funding in the Capital Reserve for the projects. Many thanks to Jim Davis for coordinating all aspects of the project.

As a reminder, next year the Town will conduct its once every five year reappraisal of all real estate within the Town. The reappraisal is required by RSA 75:8, "...so that the assessments are at full and true value." Based on recent reappraisals in area towns and increases in real estate values, we may see considerable increases in valuations in Madbury.

This is also budget season. The Select Board is currently meeting with all departments for line by line reviews of their budget proposals and capital plans. The resulting budget will be presented to the voters at the March Town Meeting. But before then, we will hold a public hearing on the proposed budget in January. We welcome your attendance at the hearing and invite your input. Please watch the Town website for notification of the hearing.

Finally, we would like to thank the Town's dedicated employees and steadfast volunteers. They accomplish truly amazing things with limited resources and keep us moving forward. Many thanks to all!

As always, residents are welcome to attend Select Board meetings and offer questions and comments. Notices of the meetings are available on the town website.

# PROPTERY TAX CREDITS AND EXEMPTIONS

If adopted by the Town, the State of New Hampshire authorizes tax credits and exemptions to property taxpayers. In Madbury, these include credits for veterans and solar energy systems, and exemptions for the elderly or blind. In certain circumstances, a tax deferral can be considered by the assessors.

A credit is an amount credited to reduce a tax bill. An exemption is an amount which reduces the assessed value of a property.

Each credit or exemption requires an application to the town. Programs are governed by qualifications and documentation requirements.

The elderly exemption has qualifications on age, residency, and income and asset levels. Veterans credits have qualifications on residency, discharge status, length of service, and disability depending on the credit.


Applications have a deadline of April 15 in the tax year the credit is applied for. The property tax year is from April 1 to March 31. Most programs are permanent; however they are subject to periodic audits.

# TIBBETTS FIELD

The Select Board would like to recognize the efforts of the Recreation Commission and in particular its Chair, Gordon Davenport, for the completion of the extension of the fitness trail at Tibbetts Field. A lot of legwork, coordination, and supervision of the project was necessary and the project has now been successfully completed. Great job, Gordon and the Recreation Commission!

Also at Tibbetts, the Oyster River Youth Association (ORYA) is preparing to start construction on a concession/pavilion/storage building in early November on Tibbetts Field. It will be a 60 x 24 ft building and replace the two existing sheds. Associated improvements include the construction of a gravel dumpster enclosure, gravel access to the new building, septic and leach field system, and a new well. The ORYA holds a lease until 2032 to use the Tibbetts Field to further its non-profit youth recreational sports activities.

# WENTWORTH FAMILY TRUST

In 2024 Bar Harbor Wealth Management, Trustee of the Wentworth Family Trust approved recommendations from Matt Bacon, Madbury Representative to the School Board. Four scholarships were awarded to Madbury students with an intent and desire to pursue a postsecondary education.

In 2024, the town received the ninth disbursement from the Trust for town purposes. The projects submitted were:

- \* \$6,000 for Tibbetts Field Trail Extension by the Recreation Commission
- \* \$7,685 for environmental testing at the Safety Complex.

# MADBURY SCHOLARSHIPS



Colin Klein (ORHS '24) was named the final recipient of the Madbury Literary Fund Scholarship this summer. Klein is a first year student at UNH, studying Biomedical Sciences.

The Literary Fund was first established in 1910 when the Madbury School District loaned the Town of Madbury \$228 from their Literary Funds, which were state funds earmarked for education from a tax on banks. This money was placed in a Fund at the Strafford savings Bank with interest from this fund to be paid to the Madbury Schools. This continued until the 1920s when state receipts ceased. Interest earned on the Literary Fund continued to be paid to the schools until 1949, when the last Madbury School was closed. Interest continued to accumulate with few withdrawals until 2012. when discussion with the State Attorney's Office advised Trustees that the fund could be expended in full. Since that time, the Trustees have used that fund to award scholarships to graduating high school seniors for use toward their higher education. With 2024's award, the fund has been fully expended and is now closed.
